Nikkei Inc. will make the following changes to the Nikkei 500 Stock Average constituents. As a result of the annual review, which is based on turnover, trading value and market capitalization, and planned delisting of a constituent due to corporate restructuring, 15 constituents of the index will be changed on March 29th, April 1st and 4th.

This annual review was conducted in accordance with "Treatment for the constituent selection of Nikkei Stock Average corresponding to the market consolidation" annuanced on June 27th 2013.
