

JPX-Nikkei 400 Net Total Return GBP Hedged Index

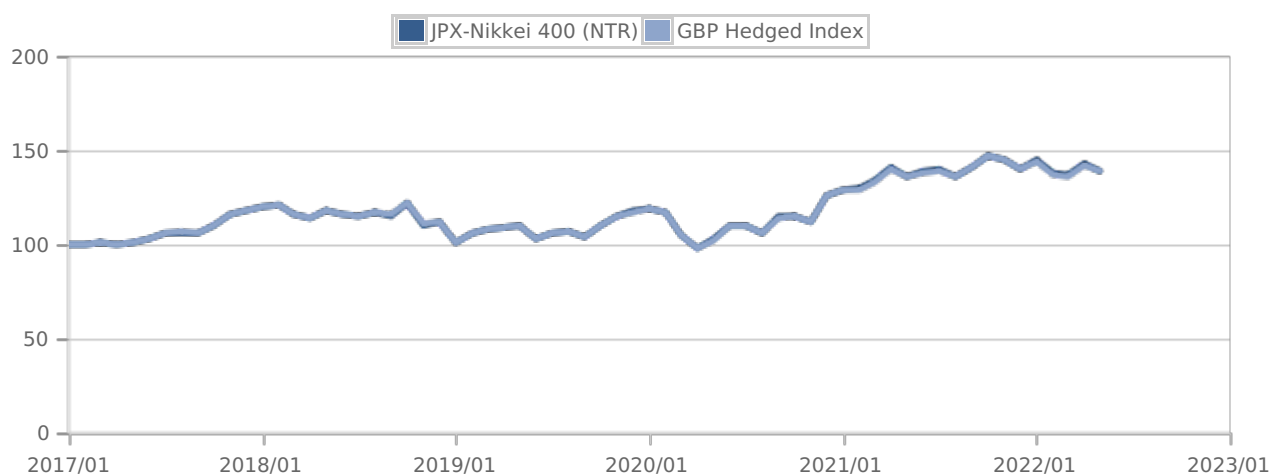
Monthly Factsheet

The JPX-Nikkei 400 Net Total Return GBP Hedged Index is one of the indices which consists of the "JPX-Nikkei 400 Currency Hedged Index" and the index measures the return of the JPX-Nikkei 400 Net Total Return Index achieved by fully hedging its currency risk for investors outside Japan i.e. non-Yen, GBP-based investors. In addition to the JPX-Nikkei 400 Net Total Return GBP Hedged Index calculated by using a monthly hedging method, the JPX-Nikkei 400 Net Total Return Daily GBP Hedged Index is also calculated by using a daily hedging method.
