

Nikkei 225 Futures Double Inverse Index

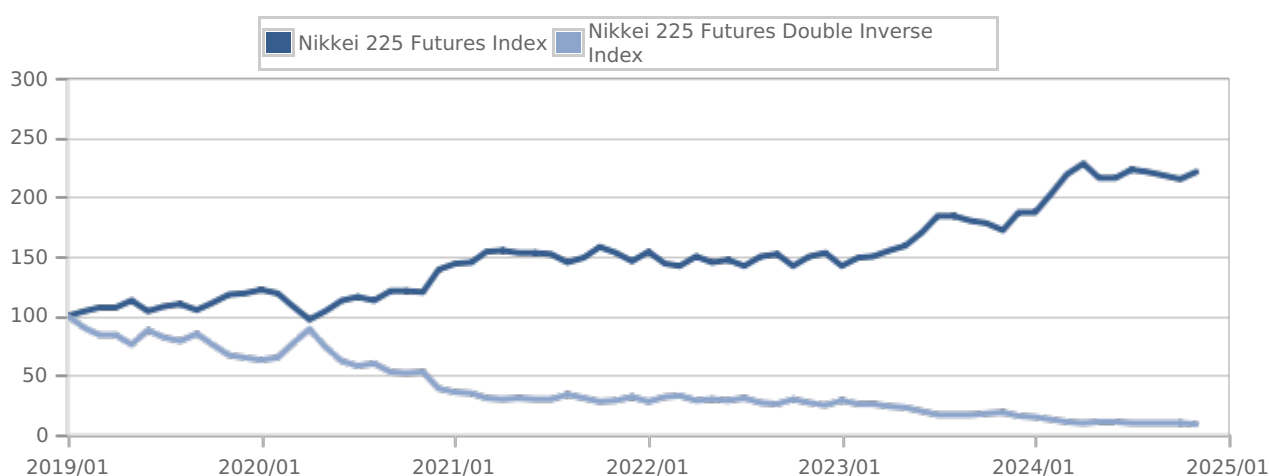
