Monthly Summary of the Tokyo Market

- In February, the Nikkei Stock Average (Nikkei 225) closed at its lowest level since September 19, 2024, at <u>37,155.50</u>, losing 2,416.99 points (6.10%) from the end of the previous month. The index notched its largest monthly percentage drop since December 2022. The yen's appreciation against the dollar, reaching levels not seen in four and a half months by late February, and uncertainties surrounding U.S. President Trump's tariff policies weighed on export-related stocks.
- Concerns over a potential trade war and negative impacts on the global economy driven by the Trump administration's tariff policies led to increased selling orders, resulting in a downward pressure on the market throughout the month. However, there were instances of market rise to mid-month, fueled by yen's depreciation. The buying of Nikkei 225 futures by overseas short-term investors, in tandem with the weaker yen, also boosted the market overall. The month's high was 39,461.47 on the 13th, and the monthly range, the difference between the high and the low on the 28th, was 2,305.97.
- The Nikkei 225 High Dividend Yield Stock 50 Index reached its highest level since the end of July 2024 on the 27th. The Nikkei Progressive and High Dividend Stock Index also climbed to its highest level since early September on the 13th, driven by buying aimed at securing dividends for the April-to-March fiscal year-end. The Nikkei Asia300 Investable Index (USD) hit a four-month high on the 21st. The substantial rise in Hong Kong's tech-led stock market lifted the index. On the same day, the Nikkei Semiconductor Stock Index also recorded its highest level in about a month before it plummeted toward the end of the month.




