Index Consultation on Postponement of Periodic Reviews for JPX-Nikkei Index 400 and JPX-Nikkei Mid and Small Cap Index

Tokyo Stock Exchange, Inc. and Nikkei Inc. (hereinafter "the Index Providers") are proposing to postpone the periodic reviews for JPX-Nikkei Index 400 and JPX-Nikkei Mid and Small Cap Index due in FY2020 and are conducting an Index Consultation on said proposal. Details are as follows:

1. Reason for postponement

According to the procedure defined in the Guidebooks, the periodic reviews for JPX-Nikkei Index 400 and JPX-Nikkei Mid and Small Cap Index are conducted on the last business day of August, using earnings reports, internal control reports and corporate governance reports¹ submitted by the periodic selection base date (the last business day of June).

On April 17, 2020 the Financial Services Agency promulgated and enforced the "Cabinet Office Ordinance on Partial Amendment of the Cabinet Office Ordinance on Disclosure of Corporate Affairs, etc." (hereinafter "Cabinet Office Ordinance") which will extend filing deadlines due to the impact of COVID-19. Specifically, for statutory reports such as annual securities reports and quarterly reports (collectively "securities reports, etc.") due between April 20 and September 29, 2020, the deadline for submission will be extended to September 30, 2020 uniformly. The Cabinet Office Ordinance will also extend the deadline for submitting internal control reports and confirmations, which are submitted with securities reports, etc. to September 30, 2020.

In addition, the Tokyo Stock Exchange Listing Department is requesting listed companies to reconsider the timing of their financial results announcements².

As there is a possibility that earnings reports, internal control reports and corporate governance reports will not be submitted by the periodic selection base date due to the

2. Proposal

(1) Outline

The periodic reviews due for FY2020 will be postponed by three months.

(2) Details

Dates including the effective date of periodic review as defined in the Guidebooks will be changed in accordance with the following table. For anything not included in the following table, the periodic review will be conducted in accordance with the Guidebook.

Financial data used in the periodic reviews shall be the earnings reports of a listed company from the fiscal year ended in April, 3 years prior to the year (in which the base date falls) to the fiscal year ended in March, immediately preceding the base date in accordance with the Guidebooks.

Submissions must specify the following: (i) Name of submitter, (ii) Occupation of submitter, (iii) Name and business type of the corporation, organization, etc. to which the submitter belongs, (iv) Contact information (i.e., phone number and email address), and (v) Opinions on the proposed matter(s).
June 29, 2020 (planned)	Final decision by the Index Providers *The Index Providers will make the final decision on the proposed matter(s) taking into consideration the opinions submitted. The finalized measures will be published on the Index Providers' official website.
