

## Annual Reshuffle of the Nikkei Asia300 Investable Index Constituents

May 17, 2024 –On June 3, Nikkei Inc. will reshuffle the constituents of the Nikkei Asia300 Investable Index, which is comprised of 300 listed companies in growing Asian economy. The index is designed to be used for financial products. Based on numerical data such as the market capitalization, trading value, sales growth and free float ratio, the periodic review is carried out in June every year.

As a result of this year’s review, 21 issues will be added, and 18 issues will be deleted.
